## Conservatory Metropolitan District Community Update January 1, 2011

As part of its ongoing effort to keep residents apprised of current matters before the Board of Directors of the Conservatory Metropolitan District, the Board intends to provide periodic updates to the community. The information contained here is only a brief summary, and residents are encouraged to attend Board meetings to learn about matters firsthand. The Board meets regularly at 9:00 a.m. on the third Monday of each month at the Conservatory Clubhouse, 2665 S. Jebel Way. Minutes of recent meetings are posted to the District's website. Entrance Lighting: We regret to report that the entrance lighting was stolen a few days after being installed at the entrances to the community located on East Hampden South Jericho Way and East Hampden and South Conservatory Parkway. The lighting system was discovered to have been stolen on December 18, 2010 only a week after being installed on December 10, 2010. The District has filed a report with the Aurora Police Department. Mailboxes: Over the past few months the District has worked extensively with the City of Aurora and the U.S. Postal Service to obtain approval to relocate some of the mailboxes currently located at South Jebel Way and South Ireland Way. The current number of mailboxes at this location is excessive compared to others throughout the Conservatory. All parties have agreed on the northwest corner of South Conservatory Parkway and South Jericho Way as an additional location. This location will house three mailbox pods serving residences in the area. Specific residents affected will receive notice individually. The District has engaged a contractor to construct the shelter at the new location and construction is expected to begin in January, weather permitting. We will keep you informed as to our progress.

<u>Groundwater:</u> The District has contracted for groundwater drainage improvements at South Jericho Way and East Garrard Drive where groundwater periodically runs across the sidewalk. The District has obtained all applicable permits from the City of Aurora for the improvements and expects to have the improvements installed by the time this update is posted.

<u>Landscaping and Snow Removal Services:</u> Summit Services has been engaged as the District's Landscaping Contractor effective January 1, 2011. Summit Services will also perform snow removal beginning this winter. The Board reviewed proposals from nine different landscape service providers and determined to engage Summit Services after careful consideration.

<u>Informational Meetings:</u> Director Palmer, is hosting quarterly informational meetings to educate residents about the Conservatory Metropolitan District. In 2010 there were a total of 12 attendees to the four meetings. You are invited to attend the next quarterly informational meeting scheduled for March 21, 2011 at 7:00 p.m. at the Conservatory Clubhouse located at 2665 South Jebel Way.
